

**FEBRUARY 16, 2021**  
**BOARD MINUTES**

Pursuant to motion of adjournment, the Polk County Board of Commissioners met in regular session at 9:30 o'clock a.m., February 16, 2021. Commissioner Warren Strandell, Commissioner Joan Lee, Commissioner Gerald Jacobson, Commissioner Willhite, Commissioner Holy and Charles S. Whiting, County Administrator, Clerk of the Board. Others present Michelle Cote, Deputy Clerk of the Board.

**REVISED AGENDA**

A motion was made by Commissioner Lee seconded by Commissioner Holy and adopted by unanimous vote of the Board to approve the February 16, 2021 revised agenda adding No. 3 under Chuck Whiting, Administration.

**CONSENT ITEMS**

A motion was made by Commissioner Willhite seconded by Commissioner Strandell and adopted by unanimous vote of the Board to approve the February 16, 2021 consent items:

WHEREAS, The Minnesota Board of Soil and Water Resources has developed policies for coordination and development of comprehensive watershed management plans, also known as One Watershed, One Plan, consistent with Minnesota Statutes, Chapter 103B.801, Comprehensive Watershed Management Planning Program; and

WHEREAS, Minnesota Statutes, Chapter 103B.301, Comprehensive Local Water Management Act, authorizes Minnesota Counties to develop and implement a local water management plan; and

WHEREAS, Minnesota Statutes, Chapter 103D.401, Watershed Management Plan, authorizes Minnesota Watershed Districts to develop and implement a watershed management plan; and

WHEREAS, Minnesota Statutes, Chapter 103C.331, subdivision 11, Comprehensive Plan, authorizes Minnesota Soil and Water Conservation Districts to develop and implement a comprehensive plan; and

WHEREAS, The counties, soil and water conservation districts, and watershed districts within the Sand Hill River Watershed (38), as delineated in the attached One Watershed, One Plan Suggested Boundary Map, have interest in developing a comprehensive watershed management plan for this area.

NOW THEREFORE BE IT RESOLVED, That Polk County recognizes and supports watershed-scale planning efforts consistent with Minnesota Statutes, Chapter 103B.801, also known as One Watershed, One Plan; and

BE IT FURTHER RESOLVED, That Polk County welcomes the opportunity to collaborate with the counties, soil and water conservation districts, and watershed districts within the Sand Hill River Watershed (39) for watershed-scale planning efforts in the future; and

BE IT FURTHER RESOLVED, That the Polk County Board of Commissioners supports an application to the Board of Water and Soil Resources for a planning grant to develop a comprehensive watershed management plan and anticipates entering into a Memorandum of Agreement with the counties, soil and water conservation districts, and watershed districts within the Sand Hill River Watershed (39), to collaborate on this effort, pending selection as a recipient of a planning grant.

**3. CSAH 21/TH 75 Discussion**

Discussion was held with the Board regarding CSAH 21/TH 75. MNDOT D2 Traffic had discussions with the Safety Office in St. Paul. They sent in an application to receive MNDOT's Share of the Highway Safety Improvement Program Funds to construct a Roundabout at TH 75/ CSAH 21 Intersection. Polk County has been asked to do the same for the counties share of HSIP Funding for year 2024 funding. Polk County has received a funding letter stating Polk County will receive 400k. MNDOT D2 is asking for 1.3 million. We are estimating total project cost at 2 million. Remainder will be paid for by MNDOT D2 and Polk County.
