Property Tax Levy

SUMMARY: At the end of the two days of department budget reviews, the Board should discuss where it would like the 2022 preliminary levy set for its September 27 Board meeting.

1. My recommendation at this point is to set the preliminary levy around a 5.0% increase over 2022, with the understanding that the final levy objective should be closer to a 3.0% increase. Option 3 therefore is my recommendation for the preliminary levy..

RESOLUTION (2022-XX)

Setting Preliminary 2023 Property Tax Levy

The following resolution (2022-XX) was offered by Commissioner:

WHEREAS, The Minnesota State Legislature passed and the Governor of the State of Minnesota signed into law, Minnesota Laws 2001, Special Session Chapter 5, and;

WHEREAS, M.S. 275.065, sub. 1 requires local taxing authorities in the State of Minnesota to establish a proposed levy on or before September 30, 2022, for taxes payable in 2023 and;

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners of Polk County that the proposed statement of expenses and anticipated receipts on file in the office of the County Administrator, for the year 2022, be and they hereby are preliminarily accepted by this Board as a proposed budget for Polk County for the year 2023 dated September 27, 2022 and that the proposed levy on the taxable property for Polk County for Year 2022 payable in 2023 be ***preliminarily*** set as follows:

[2022 levy is \$25,875,000]

Net Levy	Option 1	\$26,875,000 (+3.865%) (an increase of \$1,000,000)
	Option 2	\$27,000,000 (+4.348%) (an increase of \$1,125,000)
	Option 3	\$27,250,000 (+5.31400%) (an increase of \$1,375,000)
	Option 4	\$27,500,000 (+6.280%) (an increase of \$1,625,000)

BE IT FURTHER RESOLVED, By the Board of County Commissioners of Polk County that the time set for the 2023 Budget Public Hearing is December 13, 2022, at 6:00 p.m. in the County Board Room of the Government Center at 612 No. Broadway, Crookston.
